## Parakram Diwas: Honoring Netaji Subhas Chandra Bose's Immortal Legacy in India's Struggle for Freedom

Prime Minister Mumbai: Narendra Modi paid tribute to Netaji Subhas Chandra Bose on his 128th birth anniversary, celebrated as Parakram Diwas. He urged Indian youth to draw inspiration from Netaji's life by stepping out of their comfort zones to achieve the vision of a 'Viksit Bharat.'

Dr. Shetty emphasized the importance of conducting field trials to assess its viability and its economic impact. Divya Kumar Gulati, Chairman of CLFMA OF INDIA, highlighted the pressing issues of grain and corn shortages, emphasizing the critical need to address these challenges for

Price parity of various US grains, their derivatives, and closing grain inventories were key areas of deliberation during the meeting. This collaborative initiative underscored the importance of global partnerships in strengthening the Indian poultry industry and ensuring its resilience in the face of evolving challenges.

#### Tackling Stone Pelting on Indian Trains: Combating Vandalism on Tracks

Stone pelting on trains remains a persistent challenge for Indian Railways, endangering lives, damaging property, and disrupting services across the world's fourth-largest railway network. In 2024, a staggering 3,901 incidents were reported, including 741 attacks on Vande Bharat trains. These acts, often carried out by juveniles aged 8 to 16, stem from socio-economic frustrations, malicious motives, or even mindless thrills, according to data from the Railway Protection Force (RPF).

The consequences are severe. From physical injuries to financial losses exceeding crores of rupees, stone-pelting incidents lead to panic among passengers, delays, and additional burdens on maintenance and security resources. Historical instances, such as attacks during communal riots and protests. highlight the recurring use of trains as symbolic targets of unrest.

larly in the East Coast Railway (ECOR) zone. Measures include: Enhanced Surveillance: Deployment of CCTV cameras in trains and stations, including solar-powered and droneassisted monitoring in highrisk zones.

Physical Barriers: Installation of automatic doors, sealed windows with toughened glass, and iron-mesh designs to deter external projectiles.

Community Engagement: Awareness campaigns, local rehabilitation efforts, and collaboration with law enforcement to target crime-prone areas.

Technology and Penal Reforms: Proposals include geotagging repeat offenders, stricter penalties under the Railways Act, and recovering damages directly from perpetrators.

Prime Minister Narendra Modi and Railway Minister Ashwini Vaishnaw have prioritized modernizing the railway system to enhance passenger safety. The introduction of tamper-proof structures and advanced train designs exemplifies their commitment to building a world-class network.

While these measures show promise, long-term solutions lie in addressing the socio-economic roots of such delinquency. Educating and rehabilitating disadvantaged communities near tracks and fostering responsible citizenship can ensure safer railways. As echoed by Peter Drucker, institutions must evolve to meet new challenges, ensuring progress for a resilient and secure future.
